



# **3RD ANNUAL UPPER TOWNSHIP**

## **K-8 “REC TEAM” STINGER DUALS**

**SUNDAY, DECEMBER 9<sup>TH</sup>, 2018**

**Entry Fee:** \$400.00 (200.00 nonrefundable deposit must be received by Nov 15th)

**Location:** Upper Township Middle School 525 Perry Rd. Petersburg, NJ 08270

**Weigh-Ins:** will take place from 7:00-8:00 am (all teams must weigh in on site). Coaches Meeting at 8:30am. Wrestling will begin at 9:00 am SHARP. If you wrestle in the Upper Township Green Hornet Holiday Open on Saturday Dec 9<sup>th</sup>, your weight will count for Sunday.

**Rounds:** Round 1-9:00am, Round 2-10:30am, Round 3-12:00pm, Medal Round-1:30pm

**Team Info:** A maximum of 8 teams will be entered into the tournament. 4 Mats will be used. Teams will be allowed 2 coaches and a score keeper on the floor. Those 3 will also be given free admission to tournament. Format is subject to change if tournament is not filled.

**General Info:** This is a “Rec Level” duals, no club teams need apply. Wrestlers must wrestle for your town/rec team. Bout length will be 1-1.5-1.5 (OT is 1 min sudden death with 30 second ride out if needed). Singlets/Headgear are mandatory. Each team must supply a table worker.

**Admission:** \$5.00 for Adults...\$3:00 for kids...Under 5 years are Free

**Awards:** Team Trophy will be given to the top 3 teams.

**Dual Meet Format:** All teams will be placed into 2 pools. Teams will wrestle all teams in their pool. After completion of pool rounds...top 2 teams will wrestle for 1<sup>st</sup>/2<sup>nd</sup>, 2<sup>nd</sup> place teams in each pool will wrestle for 3<sup>rd</sup>/4<sup>th</sup>, 3<sup>rd</sup> place teams in each pool will wrestle for 5<sup>th</sup>/6<sup>th</sup> and 4<sup>th</sup> place teams in each pool will wrestle for 7<sup>th</sup>/8<sup>th</sup>. ALL TEAMS will be required to have a score/time keeper at the table for each dual meet.

**Weight Classes:** 50-55-60-65-70-75-80-85-90-95-100-110-125-150-HWT (200 MAX)  
There will be a 1lb weight allowance.
